

Key Island Features



- Main island + 28 smaller islets
- 1445 ha (2100 ha in 3D)
- 12km long,1-2km wide
- World Heritage listed
- Many threatened and endemic species
- Rugged mountains
- Settlement area approx. 350 ha
- 350-400 residents + tourists





Key Project Features

- Primary target species Black Rat and House Mouse
- 42 tonnes of Pestoff 20R cereal based pellets (Brodifacoum at 20ppm)
- Combination of aerial and hand broadcast and bait stations
- Captive management of woodhens and currawongs
- Concurrent eradication of masked owls by secondary poisoning, shooting and trapping



Biggest challenge - **People** and settlement area





How did we get here

- Rats introduced in 1918
- Long history of attempted control
- Eradication first proposed in 2001
- Draft Plan in 2009
- Funded in 2012 \$9.5M
- Project has always been divisive in the community

What have we tried in the past

- Pure science, logic and reason
- Community Hall meetings
- Workshops with subject matter experts
- Off island consultants
- Fact sheets / brochures





Change is not new, but it's still not easy







What went wrong – terribly wrong

- Pure science couldn't explain OR satisfy the emotional issues
- "It would be a great thing for the island – why don't they understand that"?
- "We didn't feel like we were included in your proposal"
- Initial consultation was reactive and didn't allow for community input.
- That was 2009 and we are still dealing with this legacy








Where did that get us

- 2015 referendum
 - 98% agreed there is a rodent problem
 - Decision to proceed made based on majority vote
- 2015 2017 Stage 2 Planning and Approvals
- Final decision Sept 2017
- Implementation in winter 2018?






How we are dealing with it

"It will kill all the birds and insects"	We are taking the species at risk into captivity
"It will poison the lagoon and coral"	Show us where this has occurred
"Rats are in equilibrium"	What about the current impacts
"Just use more poison"	Do you think that's a good option?




